Take notice that the Claimant, **Louis Vuitton Malletier** of 2 Rue du Pont-Neuf 75001 Paris, France, has commenced an action against you in the General Division of the High Court of Singapore by way of HC/OC 930/2024 (“**OC 930**”). The Claimant’s claim against you concerns infringement of intellectual property rights, including trade mark infringement.

It has been ordered that service of the Originating Claim (“**OC**”) and the Statement of Claim (“**SOC**”) in OC 930 be effected by the publication of a notice on:
